

## 2011-12 NJ TAG Reminders for DeVry Students

▪Effective with the Fall '93 semester, DeVry in New Jersey has been eligible to participate in the New Jersey Tuition Assistance Grant (TAG) program. TAG is a State (not federal) program.

*Please read the following information carefully! State grant requirements are different from Federal Aid programs in several key areas.*

▪To be eligible to receive TAG, a student must be a U.S. citizen or eligible non-citizen, enrolled in an Associates Degree or Baccalaureate Degree program, attending full-time (taking at least 12 credits), and be a New Jersey resident for at least 12 months prior to submitting his/her financial aid application (FAFSA). Please note that the parents of dependent students must also be 12-month residents of New Jersey.

▪A student must be taking at least 12 **degree** credits per semester to be considered full-time for TAG. Diploma credits are ineligible for TAG consideration. Required remedial course credits, however, can be included in determining a student's full-time status. **A student must complete a course and receive a grade to ensure that the course will count towards full-time status and eligibility for TAG. Course withdrawals, especially in the A Session of the Fall or Spring semesters, will not count towards full-time status for the purpose of TAG eligibility. Courses/credits repeated in the A and B Session of the same semester will only count once towards full-time status for TAG.**

- **Only online courses that are approved for the North Brunswick, NJ campus count in determining full-time status for TAG. Non NJ online courses DO NOT COUNT towards TAG eligibility.**

▪A DeVry Associates Degree student is **ineligible** to receive TAG, if he/she has already earned an Associates or Bachelor's degree. Likewise, a DeVry Bachelor's Degree student is also **ineligible** to receive TAG, if he/she has already earned a Bachelor's Degree.

▪Associates Degree students may receive only 5 TAG payments (5 semesters). Bachelor's Degree students can receive 9 TAG payments (9 semesters). **This includes TAG payments received at schools other than DeVry.**

▪TAG will only be paid to students for the Fall and Spring semesters. There will be **no Summer payments** under this program. **TAG payments are posted to the accounts of eligible students after full-time attendance for the semester is confirmed in the B Session.**

▪For the **2011-12** year TAG awards range from \$625 to \$5490 per term, or from \$1475 to \$10,980 for two terms (i.e. Fall and Spring terms).

**OVER**

- Students must complete a Free Application for Federal Student Aid (FAFSA) to be evaluated for TAG eligibility.
- A first time TAG recipient (e.g. most "NEW" DeVry students) must submit a FAFSA to DeVry's Student Finance/Student Central Office by 9/16/11 to be considered for Fall '11 and Spring '12 TAG awards, *or by 2/14/12 to be considered for a Spring only TAG award.* **"NEW" DeVry students who have received TAG at other schools (prior to July 2011) must submit their FAFSA's before 5/16/11.**
- Students who received TAG payments in 2010-11 or earlier (e.g. DeVry "CONTINUING" students), and who are reapplying for 2011-12 TAG awards, must submit their 2011-12 FAFSA to DeVry's Student Finance/Student Central Office by 5/16/11.
- Students must maintain satisfactory academic progress per TAG regulations to retain eligibility for payments.
- TAG has many strict deadlines and procedures of its own, which are significantly different from policies related to federal aid programs. For example, **students must respond to the New Jersey Higher Education Student Assistance Authority (HESAA) directly when information is requested directly by NJ HESAA. The staff members in DeVry's Student Finance/Student Central Office can assist, but it is the student's responsibility to respond to NJ HESAA in the time frames allotted. Failure to respond in a timely manner will typically result in the loss of TAG eligibility.**
